REPORTS

Mr. Hatcher – Mr. Hatcher stated that we received a press for the Department of Environmental Protection that we received a Recycling Tonnage Grant in the amount of \$52,493. This is approximately 40% higher than previous years. A lot of credit goes to Jerry DeSanto who files the application as the Recycling Coordinator.

Mr. Hatcher reported that we received word from the Township Engineer that the work on the 2012 Road Program will begin next week.

The development will include a nice restaurant, a Popeyes, a drive-thru Starbucks and some other retail stores and office space.
