### **PSE&G PROJECT UPDATE**

Mr. Reichle, Sr. Project Manager for PSE&G, reported that the underground work on Hartford Road and at the Route 130 Bridge has been completed. The underground work on Bridgeboro Road will start in April and end in December of 2024. Mr. Reichle continued to give an update on the work taking place in Delran. He thanked the township, CME and Burlington County for their help in facilitating the improvements.

Mr. Catrambone – Mr. Catrambone reported that the repair of the sewer main at Fifth & Leon has been completed. The roadway will receive a temporary patch very soon so that the road is passable. Mr. Catrambone thanked everyone involved for their help in dealing with this unexpected issue so quickly. He also thanked Delran residents who limited their use of water during the emergency.

Mr. D'Armiento – No report

Mrs. Apeadu – Mrs. Apeadu thanked everyone who helped with the recent flooding in Riverside Park. She stated that there will be a town hall meeting at the municipal building on Wednesday, January 31<sup>st</sup> at 7:00 PM. The meeting will discuss what needs to be done to fix the flooding issue. Mrs. Apeadu thanked the sewer team and everyone who helped with the recent sewer main break. She also thanked Calvary Church for hosting the emergency teams on short notice.

**Mr.** Jeney – Mr. Jeney also thanked everyone who helped with the recent catastrophes in the township.

Mr. Burrell – Mr. Burrell invited everyone to attend the town hall meeting on January 31<sup>st</sup> at 7:00 PM. He explained that there will not be a problem paying for the recent sewer main break due to good financial management within the township. Mr. Burrell thanked the many people and organizations who helped during the last few weeks.

#### **PUBLIC COMMENT**

Mr. Jeney made a motion, seconded by Mrs. Apeadu to open the meeting to the public All were in favor; the motion was approved.

Jennifer Reppert, Delran – Ms. Reppert asked what authority the drone ordinance falls under, stating that she feels her rights are being taken away. Mr. Burrell stated that municipalities can make decisions regarding a drone ordinance. He explained that the ordinance is being put in place to give police the ability to intervene if a resident's privacy is being invaded. Mr. Jeney added that he attended a drone seminar at the League of Municipalities. He stated that there are many communities that already have these ordinances in place.

Mary Janus, Delran - Ms. Janus expressed her concern regarding possible illegal aliens who are living in Delran Township and attending school here. She asked the mayor what incentives are being offered to the township so that illegal aliens can reside here. He stated that the township is not involved with the process of placing illegal aliens in Delran Township and does not receive

any incentives. Mr. Catrambone also explained that he and council have nothing to do with the school system. Mr. Burrell commented that there is a retired police officer on staff at the school who makes sure that students are legally able to attend classes. He suggested that Ms. Janus contact the school system with her concerns. Mr. Jeney mentioned that he was on the school board for 16 years and accusations such as these were always investigated.

Pam Geary, Delran – Ms. Geary commented that since New Jersey is a sanctuary state and illegal aliens are being sent here, the mayor and council must know about them. Mr. Burrell explained that there is no notification given to the government officials in Delran Township regarding this issue.

Mr. Jeney made a motion, seconded by Mrs. Apeadu to close the meeting to the public All were in favor; the motion was approved.

Mr. Jeney made a motion to adjourn the meeting, seconded by Mrs. Apeadu. All were in favor; the meeting was adjourned.
