REPORTS

Mr. Hatcher – Mr. Hatcher stated that the Public Works Department began recycling Christmas trees this year. They were able to recycle seven hundred trees. They turned the trees into mulch.

Mr. Hatcher stated that the Burlington County Joint Insurance Fund had their annual safety kick-off breakfast. We earned the silver program this year. We fell short on one of the meetings. We had recognition for reducing our loss time accident rate from 5.99% to 2.62 %. We received recognition for having 100% of our workers comp cases on light duty. The Police Department received a special achievement award for the ready buckle program. Kathy Walter and Larry Jack also received special recognition for running the Biggest Loser program for the employees. Both programs were funded through the safety program. We thanked everyone involved in the safety program.

Mr. Long – No report.

Mr. Bauer – Mr. Bauer, Fire Commissioner, stated that in Delran there have been no notable events in the last month. We have assisted Mt. Laurel and Willingboro. The heavy rescue and two ambulances assisted in the Edgewater Park accident. The heavy rescue also assisted today in Cinnaminson.

One event that did happen in town was that on Creek Road there was an accident last night that shut down the road and brought down some wires.

During the small storm on Friday night, they had several brush fires and also a mulch fire.

Mr. Morrow congratulated him on his reelection as a Commissioner and also on getting the budget passed.

Mr. Paris stated that the Delran Fire Department hot wheels car in out in stores.

Mr. Moran – Mr. Moran congratulated Michael Brady on receiving his Eagle Scout rank.

Mr. Moran stated that the Department Heads working together is how safety is achieved. He asked Mr. Hatcher to thank everyone for their work.

Mr. Moran stated that we will no longer be having an Environmental Advisory Agency. He wanted to recognize Gina Reed for her service.

Mr. Moran stated that we are working on the budget and the Governor has released the aid numbers today.
