REPORTS

Ms. Eggers – No report.

Mr. Hatcher – Mr. Hatcher reported that the dumpster drop-off is scheduled for the weekend of April 20th.

Mr. Hatcher reported that the damaged netting at Delran Community Park has been taken down and the field is now playable. An insurance claim has been submitted. We have contacted vendors to repair the backstop at Notre Dame Field and will get done as soon as possible.

Solicitor – No report.

Mr. Schwartz – Mr. Schwartz stated that he received several calls today from residents indicating that they received tax bills stuck to theirs that belonged to other residents. Mr. Schwartz asked if they should be returned to the Township.

Mr. Hatcher stated yes.

Mr. Schwartz thanked Public Works for the excellent job handling the cleanup from the horrendous weather the past few weeks.

Mr. Burrell – Mr. Burrell announced that on August 7th Delran will be participating in Nation Night Out, hopefully at Community Park. They are in the early planning stages and if anyone is interested in helping with the event they can reach out to the Mayor or anyone on Council. Stay tuned to the Township website and Facebook for updates.

Mr. O'Connell – No report.

Mr. Catrambone – Mr. Catrambone reported that there will be a ceremonial ground breaking for Jake's Place at Community Park on June 7th. Information will be posted on the website and Facebook. Hopefully the build will be scheduled for September.

Mr. Catrambone stated that some repairs have been made to the Heritage Square parking lot.

Mr. Catrambone stated that Al Bucci, Sr. passed away over the weekend. He was a veteran's advocate and passed Commander of the VFW Post 3020. On behalf of the residents of Delran, we mourn his passing.

Mr. Paris – Mr. Paris stated that a lot of people take the Public Works Department for granted but they have done a fantastic job this winter.

Mr. Catrambone – Mr. Catrambone stated that at a prior work session we asked the staff to do a better job at getting the information out regarding storm regulations. It seems to him that it worked with this last storm and he thanked the staff for their efforts.

PUBLIC PORTION

Mr. Burrell made a motion, seconded by Mr. O'Connell to open the meeting to the public for any questions. All were in favor, the motion was approved.

Bob Gilbert, 75 Stewart Avenue, stated that aside from being a veteran's advocate Mr. Bucci also helped get the law passed for the work being done by the Mission of Honor. The Mission of Honor provides a proper military burial for unclaimed remains of veterans. They have the remains of twenty veterans waiting to be buried. They have already buried over 215 in General Doyle's Cemetery and have reunited 298 with relatives.

Mr. Gilbert stated that a resident on Facebook brought up her concerns over the park on Notre Dame including used condoms and broken glass. Mr. Gilbert asked who they can contact to report these issues.

Mr. Paris stated that they can reach out to Mr. Hatcher or Public Works. They have been extremely busy but the resident reports the issue they will get it taken care of.

Mr. Hatcher stated that they normally clean the parks every Monday but he will report this issue to the Superintendent.

Mr. Burrell reported that the Green Team is hosting a park clean-up this Friday. If enough residents show up maybe we can add Notre Dame Field to the list.

Mr. Gilbert stated that he saw that notice but did not see Notre Dame Park included as well as Friendship Park on Stewart Avenue.

Mr. Burrell stated that the reason certain parks were included is their proximity to the schools in order for the students to be able walk or be bused.

Mr. Catrambone reminded residents that have any issue, please contact the Township. When posting on Facebook it may or may not get to us.

Joe Biluck, 510 Leon Avenue, stated that he is attending tonight on behalf of the School Board where he serves as Vice President. Mr. Biluck stated that it is safe to say that everyone in this room has been touch by a tragedy either personally or through a loved one or friend. Typically once the tragedy occurs, statements are usually made such as I wonder what we could have done to prevent that tragedy or is there something we can do to avoid it in the future. Recently the Board of Education passed a tentative budget that includes over \$1,000,000, most through capital reserve, that is allocated to improve student and occupant security in all of the schools. On behalf of the Board of Education, we are urging Council to reflect on their current spending plan and consider playing a greater role in participating in the activity of securing our schools to a greater level. No one wants to see the tragedy that happened in Parkland, FL happen again. The Board of Education is looking to partner with the Township Council to play a greater and more sustained role in the safety and security of our most precious and vulnerable members of this community. We would like to continue the conversation in hopes that we can develop a partnership moving forward to ensure the tragedy that happened in Parkland and across the country never happens in this town. Mr. Biluck thanked Mayor and Council for their time.

Mr. Catrambone thanked Mr. Biluck for his comments.

Mr. O'Connell made a motion to close the meeting to the public, seconded by Mr. Burrell. All were in favor, the motion was approved.

Mr. Schwartz made a motion, seconded by Mr. O'Connell to adjourn the meeting. All were in favor, the meeting adjourned.
