TOWNSHIP OF DELRAN

ORDINANCE 2021-07

AN ORDINANCE REPEALING CHAPTER 12," TRAFFIC", SECTION 12-3.8, "SNOW REMOVAL", OF THE CODE OF THE TOWNSHIP OF DELRAN AND REPLACING WITH NEW CHAPTER 12, "TRAFFIC", SECTION 12-3.8, "SNOW REMOVAL."

SECTION ONE. Chapter 12, "Traffic", Section 12-3.8, "Snow Removal", of the Code of the Township of Delran, be and the same is hereby repealed and replaced thereto with the following:

Chapter 12

§12-3.8 Snow Removal:

A. During an actual emergency or disaster, or a forecast emergency or disaster in Delran Township, the Delran Emergency Management Coordinator or, in his absence, a Deputy Emergency Management Coordinator or designee may issue an emergency proclamation as authorized by state law (NJ Civil Defense Act of 1942, amended and supplemented by Chapter 251, P.L. 1942) designating that there shall be no parking upon those streets or parts of streets identified in the emergency proclamation. The emergency proclamation will establish a date and time of commencement, and a superseding emergency proclamation will be issued establishing a date and time for the termination of such emergency.

B. These regulations shall be in addition to and supplement all other laws of the State of New Jersey, the County of Burlington, and the Township of Delran.

C. Notification as to the date and time of the commencement of such declared emergency, as well as the date and time of the declaration of the end of such emergency, may be made by any or all of the following: Township Reverse 911; Township website; news media.

D. Removal of vehicles. Any unoccupied vehicle parked or standing in violation of this article shall be deemed a nuisance to the safe and proper regulation and movement of traffic, and any police officer may provide for the immediate removal of such vehicle. The owner shall pay the reasonable costs for the removal and storage which may result from such removal before regaining possession of the vehicle.

E. Violations and penalties. The fine for violation of this article shall be \$50, plus court costs, which may be paid through the Municipal Court or imprisonment for a term not exceeding 15 days, or both.

SECTION TWO. Chapter 12, "Traffic", Section 12-3.8, "Snow Removal", be and the same is hereby amended.

SECTION THREE. Each section, subsection, sentence, clause, and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION FOUR. This Ordinance shall take effect on upon its passage and publication according to law.

EMERGENCY TEMPORARY APPROPRIATIONS N.J.S.A. 40A:4-20 EXTENDING THE TEMPORARY BUDGET PERIOD THROUGH MAY 5, 2021

WHEREAS, N.J.S.A. 40A:4-20 provides for additions to the adopted Temporary Appropriations as necessary prior to adopting the annual budget for the purposes and amounts required; and

WHEREAS, in January of 2021 the Township Committee approved a \$3,608,676.78 Temporary Budget to provide funding until the 2021 budget is adopted; and

WHEREAS, the budget calendar contemplates adopting a budget before April 30; and

WHEREAS, current fiscal and economic conditions caused a delay in the budget process; and

WHEREAS, it is now necessary to extend the Temporary Budget through May 5, 2021.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Delran, County of Burlington and State of New Jersey, that the total Temporary Budget Appropriations for 2021 inclusive of this Emergency Temporary Budget Appropriation shall not exceed \$ 4,811,569.04 for operating and debt appropriations until such time that the 2021 Budget is adopted approved by the Division of Local Government Services.

EMERGENCY PROCUREMENT RESOLUTION

WHEREAS, an emergency has arisen with respect to the sanitary sewer line south of the intersection of Fairview Street and Route 130; and

WHEREAS, N.J.S. 40A:6-11 provides for the ability to enter into a contract in such an emergency without going through the competitive bidding process which includes Pay to Play regulations; and

WHEREAS, the total amount of emergency is \$26,276 which is below the bidding threshold but above the Pay to Play limit, and

WHEREAS, due to the nature of this sanitary sewer line emergency that exists in front of the driveway of a commercial property and needs immediate attention.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Delran, Burlington that the Township enter into a contract with Standard Pipe Services, LLC to make the necessary repairs in conformance with N.J.S.A 4OA: 11-6.

BE IT FURTHER RESOLVED that the Township has the necessary funds available for this repair in a previously reserved account for the repair to the Route 130 Sanitary Sewer Line.
