#### 2014 MUNICIPAL BUDGET

#### TOWNSHIP OF DELRAN RESOLUTION 2014-41

If there is no county library located within the municipality, then it must be provided to any county library in the county wherein the municipality is located. Further, the public officer delegated the responsibility for delivery of the copies to said libraries has completed a certification forwarded to the governing body that such deliveries were made and copies have been made available by the Clerk to persons requesting them; and

# PUBLIC HEARING 2014 BUDGET

Mr. Hatcher gave a synopsis of the budget. There is no tax increase and also no rate increase within the sewer budget. The municipal budget is \$15,735,543.00 which is \$50,457.00 lower than last year. The local purpose rate will remain the same at .756 per \$100 of assessed valuation. Therefore, the average assessed home of \$209,000 will pay \$1,580.04 for the local purpose, recognizing that this is only a portion of the tax bill. The local purpose portion represents about 22% of your total tax bill. The average tax bill including all entities will be about \$7,076.00. The amount to be raised by taxation in the municipal budget is \$10,610.00, down by \$39,000 from last year. Overall spending is down, the amount to be raised through taxation is also going down. The four elements that helped us were consistent revenues, especially in the area of tax collections, controlling spending, and managing the surplus. In this budget, we will again use \$2,700,000 in surplus to balance the budget. We are also experiencing a one year reduction this year in debt service. Areas that will be a concern moving forward, will be tax appeals, business relocations and shutdowns, national and state economy and foreclosed and abandoned properties.

The sewer utility budget this year is \$3,030,000.00. This is a reduction of \$326,000 from last year's budget. The fund balance is beginning to return to an acceptable level. It has gone from \$1,873,884 to \$2,304,261 at year end 2013.

After the public hearing tonight we will need to approve, by Resolution, amendments to the budget, none of which affect the overall numbers.

Mr. Morrow made a motion to open the meeting to the public for comments on the 2014 Municipal Budget, seconded by Ms. Pangia. All were in favor, motion approved.

# **REPORTS**

**Ms. Eggers** – No report.

**Mr. Hatcher** – Mr. Hatcher reported that the 2014 sewer bills have been mailed. They are due before April 30<sup>th</sup> to avoid any late fees.

Branch collection and leaf pick up have begun today. Leaf collection will run until April 30<sup>th</sup>. Branch collection will extend until October 1<sup>st</sup>.

Mr. Long – No report.

**Mr. Bauer** – Mr. Bauer, Fire Commissioner, reported on a port-a-pot fire at Leon Avenue that happened last night. As comical as this may be, it was obviously set on fire deliberately. While they were there fighting the fire a resident approach them and told them someone also tried to set the one on fire at Brown Street. We are investigating this and will keep an eye on the issue. Hopefully, we can catch the individuals before this gets out of hand.

We also had a major structure fire off of Stoneham Drive. The fire was a kitchen fire due to the stove being left unattended.

**Ms. Pangia** – Ms. Pangia apologized for being a little late she was on the phone trying to help a resident.

On April 22, 2014, the mammogram van will be coming back.

Also, on April 22<sup>nd</sup> at 6:00 P.M., there will be a volunteers meeting for the Farmers' Market. This year we will be doing theme weeks. We are hoping to get residents involved in the Farmers' Market

Ms. Pangia thanked the ladies in the Tax Office. One of the workers saw a post on her Delran Events Facebook page regarding the sewer bills and she jumped on and responded on a Sunday afternoon. It shows dedication by our employees and it was greatly appreciated.

Ms. Pangia sent well wishes to Councilman Mike Schwartz who is still ill but is on the mend.

Mrs. Kolodi – Mrs. Kolodi had no reported.

**Mr. Morrow** – Mr. Morrow updated the residents about the shopping center on Fairview Street. The company that purchased the property has been in contact with the Township and we should be seeing activity within the next thirty days. They will be addressing the concerns that we brought before them, such as additional parking lot lighting, damage to the catch basin, curbs and the overlay of the parking lot. We will be keeping on top of this issue if nothing is done within the thirty days.

**Mr. Catrambone** – Mr. Catrambone reminded everyone to please keep the branches and leaves separate.

Mr. Catrambone reported that this evening we have adopted our municipal budget and made note of some of the things that have gotten us to this point. A while back we made the decision to spend the money for a town wide reassessment. Because of the way the real estate market was going, we were anticipating numerous tax appeal and doing the reassessment has paid off for us. While we have had tax appeals, we have not been faced with the number nor the volume that he sees in other municipalities. In addition to the budget remaining the same we have set up an account for a reserve for snow removal and also increased the budget for road repair by 25%. The road program budget increase from \$800,000 to \$1,000,000. The amount that we have raised by taxation over the last five years has been 1.2%. That means we are average .24% per year. We are indeed indebted to the hard work of the Department Heads along with Mr. Hatcher and Mayor Paris, who work long and hard to bring these numbers to Council. They have all work worked to keep this budget where it is and taxes stable. We are proud to say that there is a zero increase this year.

**Mr. Paris** – Mr. Paris reported that he wanted to add a few things regarding the budget. With the reassessment that we had, Tom Davis, our Tax Assessor did a fantastic job. He notified us that it was the right time to do the reassessment. Also, the Department Heads and staff continue to do a fantastic job. We continue to lose workers through attrition and some we have not replaced, so departments are working short staffed. We having been cutting back the budget for years now but next year it will be more of a challenge because there is not much more to cut. We will continue to look at shared services, additional

revenue possibilities and bringing businesses into town. We will do everything we can to try and keep the budget flat again next year.

Mr. Paris reported that in regards to the port-a-pot issues when he heard about this today he was very disappointed. He would like to catch the individuals that are doing this. We have had issues with vandalism in many of our Township parks and we will do everything we can to prevent this.

**Mr. Catrambone** – Mr. Catrambone reminded everyone that the Easter Egg Hunt will be on Saturday, April 12<sup>th</sup> at noon at Conrow Park. We suggested everyone get there early. There will also be a special needs section added this year. He applauded the RAC for putting this together.

# PUBLIC PORTION

Mr. Morrow made a motion, seconded by Mrs. Kolodi to open the meeting to the public for any questions. All were in favor, the motion was approved.

Dolores Cannone, 910 Hubbs Street, asked if there is any property that the Township is interested in for open space.

Mr. Catrambone stated that the money that is in the open space fund and scheduled to come into the open space fund has been committed for the debt services on the properties that we have already purchased. Unless something changing we have utilized the money in the fund to preserve the properties we have already purchased.

Dan O'Connell, 5 Springcress Drive, stated that when he read in the paper that the taxes were staying flat he wanted to attend the meeting to say thanks. He has lived in the community since 1992 and loves it here. He is happy to live in a community where the residents approved full day Kindergarten and where we have parks for our old and young residents to enjoy. The quality of life here is great and keep up the good work. For the record, I am single and have no children but I do not mind paying the taxes for a town like this.

Mr. Morrow made a motion to close the meeting to the public, seconded by Mrs. Kolodi. All were in favor, the motion was approved.
