Mr. Bellina – Mr. Bellina reported that the Notre Dame project will go out to bid tomorrow. The bid opening will be about two weeks away. The project will commence this Fall.

Ms. Eggers – No report

Mr. Catrambone – Mr. Catrambone stated that the tax bills are out and taxes will be the same amount as last year. Mr. Catrambone thanked Mr. Bellina for helping him present a no-increase budget. He also thanked the department heads and Council.

Mr. Catrambone reported that The Mason Williams Foundation is hosting their Back to School Mental Health Challenge and Fair on September 18th. They are looking for support from the township. Mrs. Apeadu – No report

Mr. Jeney – Mr. Jeney announced that The Green Team is sponsoring a program called "Everything Water" at the Delran Community Park this Thursday. Water, water usage and water preservation will be discussed. Attendees are encouraged to bring a picnic dinner at 6:30 PM. The presentation will follow.

Mr. Jeney reported that they are working with the VFW Post 3020 to identify another veteran who will be honored at the public meeting in September. Mr. Jeney thanked Sean Huryn, the vice commander, for all of his work and support.

Mr. Burrell – Mr. Burrell congratulated Jeremy Rafanello, a Union soccer player who was raised in Delran Township.

PUBLIC COMMENT

Mr. Jeney made a motion to open the floor to public comment, seconded by Mrs. Apeadu. All were in favor; the motion was approved.

Joseph Joyce, Delran resident – Mr. Joyce stated that people who have spoken out at Council meetings have suffered retaliations. He noted the termination of the communications director's contract over allegations that she wrote a blog accusing Mr. Duff of faking cancer. He stated that her termination should have happened when the evidence was first produced. Mr. Joyce asked Mr. Catrambone to resign his position as mayor due to poor decisions. He requested this as a citizen of Delran and in no way should this be considered a political statement.

Mr. Burrell declared that the Mayor and Council definitely do not condone any type of violence and that incidents should be reported to the police.

Barb Littleton, Delran, NJ – Ms. Littleton explained that she feels the mayor is good at heart but the decisions he has made have not been good for the residents of Delran Township. In addition to the Dunphy's law suit and the Carli Lloyd event, Ms. Littleton explained that residents have been asking whether the township is covered if the communications director does something that results in a court case. Ms. Littleton reported that the communication director's insurance was not valid at the time of the post she is accused of publishing. Ms. Littleton also asked for the mayor's resignation.

Patrick Duff, Haddon Heights, NJ – Mr. Duff explained that he was determined to find out who created a blog that accused him of faking cancer and stealing money from a memorial. Mr. Catrambone stated the he denounced the blog when it came out and he does not believe that his personal assistant wrote it. Mr. Duff reported her cell phone was directly attached to the blog and asked why she was fired. Mr. Catrambone stated that he was not involved in that decision. Mr.

Duff explained that he has filed a defamation lawsuit and the township is liable.

Candy Cure, Delran, NJ - Ms. Cure stated that the Green Team event is being held, tomorrow, Wednesday, August 24^{th} not Thursday.

Jen Reppert, Delran, NJ – Ms. Reppert expressed her concerns about the current happenings in the township and asked that the mayor and Council do the right thing.

Ian Smith – Mr. Smith explained that Mr. Duff is a good human being who assists people that don't know how to get help. He stated that Mr. Duff and everyone who supports him, will not let the current issues go. He advised the mayor and Council to do the right thing.

Mr. Jeney made a motion to close the floor to public comment, seconded by Mrs. Apeadu. All were in favor; the motion was approved.

Mr. Burrell thanked everyone who spoke or supported the speakers tonight by being at the meeting. He remarked that he shares the frustrations of the people who came to the meeting. All of the employees of the township have had to deal with the current controversies. He stated that he feels the people want accountability. He explained that Council has done their best to be accountable by previously getting rid of the township solicitor and by terminating the contract of the communications director this evening. Mr. Burrell stated that he would like answers from the mayor because until that happens, it will be very difficult to get anything except the day to day running of the township done. He discussed the standard of conduct that is acceptable for elected officials. He advised that the mayor should strongly consider what the residents have suggested tonight.

Mr. Catrambone stated that he appreciated the comments of Mr. Burrell but he noted that everything related to Dunphy's was Council approved. The Carli Lloyd Event was handled by Council and the RAC. Mr. Catrambone explained that this is a heartbreaking situation but that he was elected to do a job and he has no intention of resigning.
