REPORTS

Chief Kevin Peak, Delran Fire Department reported 434 calls for service. There was an oven

fire on August 9th that burned itself out in the 1100 block of Fairview Street. Riverside Township and the FM assisted with that call.

On August 17th, the Chester Avenue Station was dispatched to Station 171 in Vincentown where they offered coverage and help on the scene of a multi-alarm fire at Mount Holly Motor Sports.

On August 21st, the rehab from the Chester Avenue Station was dispatched to Sheffield Drive in Mansfield. The rehab provides shelter, water, EMS supplies, etc.

On August 22nd, the department was dispatched to Carriage Lane for a car fire.

On August 28th, Bridgeboro Road Station was dispatched to Moorestown for a fire in the sunroom of a house.

On August 29th, the Delran Fire Department visited the Chester Woods apartment complex so they could get an idea of the structures and educate themselves as to how best to handle any emergency situations that may arise there in the future.

Fire Prevention Week will be in October. The fire department will be at Home Depot and Lowes for their Fire and Safety Days. October 22nd is slated for the fire department's open house for fire prevention and safety.

Mr. Burrell thanked the fire department for their responsiveness when his fire alarm went off late at night.

Mr. McSweeney, Delran Emergency Squad reported that the emergency squad answered 304 calls in July and 298 calls in August. In August, Delran handled 226 of the calls with 72 going to mutual aid. Mr. McSweeney explained that other towns provide backups when Delran ambulances are unavailable and Delran reciprocates that service.

The COVID clinic is still being run on Tuesdays and Thursdays.

An application to conduct an EMT program in Delran has been submitted to the board of health.

A financial audit has been completed for 2021. The audit was favorable and required no changes be made. The report is available if needed.

Mr. McSweeney stated that the emergency squad is looking forward to Delran Night Out and the winter festival.

Mr. Bellina – Mr. Bellina reported that PSE&G is starting work on their new substation in the vicinity of Hartford Road near the Summerhill development. PSE&G will give updates on the project in December or January.

Mr. Smith – Mr. Smith congratulated Art Saul and stated that he loves that the township takes the time to recognize residents who have served their country. Mr. Smith advised residents to watch out for deer and other wildlife while driving.

Mr. Jeney – Mr. Jeney pointed out all the behind the scenes training and the time commitment that members of our emergency services volunteer for. He congratulated all of our emergency response people for their dedication and effort.

Mr. Burrell – Mr. Burrell stated that an executive session will be added on after the public comment portion of the meeting.

PUBLIC PORTION

Mr. Smith made a motion, seconded by Mrs. Apeadu to open the meeting to the public for any questions. All were in favor; the motion was approved.

Bob Gilbert, 75 Stewart Avenue reported that The Mission of Honor/Vietnam Veterans of America will be burying 7 more cremains on Thursday, January 15th. The cremains have been abandoned. Mr. Gilbert stated that Mr. Jeney has been to a service in the past and found it to be very moving. The service will be at General Doyle cemetery and should start at approximately, 1:00 PM. Mr. Gilbert offered a ride for up to three people who would like to attend.

Mr. Gilbert explained that the process entails going to funeral homes to look for the cremains of veterans who have been there for a while. The funeral director sends a letter and if it is deemed that the cremains are unwanted or abandoned, the process moves forward and eventually the cremains can be given their final resting place.

Mr. Jeney remarked that when he attended the service with Mr. Gilbert, it was awesome to see the respect given to veterans who have no one.

Mr. Gilbert explained it's an ongoing process and it's the least we can do for these forgotten veterans. He stated that less than 1% of this country protects the other 99%

Mr. Smith asked Mr. Gilbert if the service was actually Thursday, September 15th, not January 15th as was previously stated. Mr. Gilbert confirmed that the service is on September 15th.

Joan Kerstetter, 10 River Drive thanked Council for the landscaping that was done along the riverbank. She also asked about the entrances/exits for the Chester Woods development on Chester Avenue. Mr. Burrell stated that he can get that information. He reported that there will not be a traffic light at that intersection.

Christine Etsell, 8 River Drive asked if there has been any communication between the township

and the Army Corp. of Engineers. Mr. Bellina explained that Mr. Winckowski, the township engineer, has reached out a number of times but has not heard anything back yet. Mr. Bellina stated that we will keep on top of them. Mr. Burrell explained that they have committed to the study but things can move slowly.

Mr. Jeney made a motion to close the meeting to the public, seconded by Mr. Smith. All were in favor; the motion was approved.

Mr. Bellina added that he and Mr. Winckowski met with Ms. Etsell a few weeks ago to investigate her report of a drainage issue on River Road. Corrective action will be taken soon.

Mr. Smith made a motion, seconded by Mrs. Apeadu to adopt Resolution 2022-173A.


