AN ORDINANCE TO ESTABLISH SALARIES FOR VARIOUS EMPLOYEES WITHIN THE DELRAN TOWNSHIP POLICE DEPARTMENT IN THE TOWNSHIP OF DELRAN, COUNTY OF BURLINGTON, STATE OF NEW JERSEY AND REGULATING THE MANNER OF PAYMENT OF SAME

**BE IT ORDAINED** by the Township Council of the Township of Delran in the County of Burlington and State of New Jersey that:

Mr. Catrambone advised residents who will be on the roads in town, to watch for students who are participating in homecoming activities this week. He congratulated the kids and parents who are participating in this great event in town.

**Ms. Rizzuto** – Ms. Rizzuto reported that upon review of the 2021 Delran Township Municipal Audit and the corresponding corrective action plan that was adopted at the last meeting, the NJ Office of the Comptroller has determined that it will no longer seek to take the interviews of the three individuals that were previously identified. Therefore, all legal review with this matter has ceased.

Mrs. Apeadu – Mrs. Apeadu stated that she spoke with some of her constituents and she received a referral from one of the residents in Ward 1. As soon as she gathers some additional information, she will forward it over to the office.

**Mr. Smith** – Mr. Smith congratulated Petty Officer Second Class, Donald Seymour. Mr. Smith stated that he loves that the township is recognizing the veterans in town, giving us an opportunity to hear about their accomplishments.

Mr. Smith also reiterated the mayor's warning about watching people who are involved in the homecoming festivities.
