TOWNSHIP OF DELRAN ORDINANCE 2014-19

ORDINANCE OF THE TOWNSHIP OF DELRAN AMENDING AND SUPPLEMENTING CHAPTER 257 OF THE CODE OF THE TOWNSHIP OF DELRAN ENTITLED "PROPERTY MAINTENANCE"

WHEREAS, the Township Council of the Township of Delran ("Township") has reviewed recent amendments to Titles 2A, 40 and 46 of the New Jersey Statutes regarding vacant and abandoned property and the responsibilities of foreclosing creditors; and;

WHEREAS, as a result of such legislation, certain amendments to the Code of the Township of Delran are required;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Township Council of the Township of Delran that the following provisions of the Code of the Township of Delran are amended as follows:

SECTION 1. "Article III" is hereby added to Chapter 257 and shall be entitled "Property Maintenance by Creditors" and shall add the following new sections which shall read as follows:

§257-19 Creditor Responsibility. Pursuant to the provisions of the Public Laws of 2014, Chapter 35, a creditor filing a summons and complaint to foreclose a lien on a residential property that is vacant and abandoned, whether the filing of the summons and complaint is made before or after a determination that the property is vacant and abandoned, shall be responsible for the care, maintenance, security, and upkeep of the exterior of the residential property. This obligation applies whether the determination that the property is vacant and abandoned is made by the public officer pursuant to the provisions of this Chapter, any other Chapter of the Code of the Township of Delran, pursuant to the provisions of N.J.S.A. 2A:50-73 or otherwise.

§257-20 Notice to creditor; time to correct violations. If the public officer, or other authorized municipal official, determines that a creditor obligated to care, maintain, secure and keep up a vacant and abandoned property has failed to do so in violation of the provisions of this Chapter or any other Chapter of this Code, the public officer or other authorized municipal official shall issue a notice of violation to the creditor that has

filed a summons and compliant to foreclose on the property in question. The notice shall require the person or entity to correct the violation within thirty (30) days of receipt of the notice, or within ten (10) days of receipt of the notice if the violation presents an imminent threat to public health and safety. The issuance of this notice shall constitute evidence that a property is "vacant and abandoned" for purposes of N.J.S.A. 2A:50-73.

§257-21 Designated representative of out-of-State creditor; violation. An out-of-State creditor shall include the full name and contact information of the in-State representative or agent in the notice required to be provided to the municipal clerk pursuant to paragraph one of N.J.S.A. 46:10B-51. An out-of-State creditor found by a court of competent jurisdiction to have violated this provision shall be subject to a fine of \$2,500.00 for each day of the violation commencing on the day after the 10 day period set forth in paragraph one of N.J.S.A. 46:10b-51 with respect to notifying the municipal clerk that an action to foreclose on the property has been filed.

§257-22 Violations and penalties. Except as set forth in §257-21 and herein, any person, firm, corporation or entity violating any provision of this Article shall, upon conviction, be punishable as provided in Chapter 1, General Provisions, Article I, of this Code. A creditor required to care, maintain, secure and keep up a property under this Chapter cited in a notices issued pursuant to §257-20 shall be subject to a fine of \$1,500.00 for each day of the violation.

§257-23 Additional notice required. Notice of violations of property maintenance, building or other property codes for any property declared vacant and abandoned pursuant to this Article shall be given to a foreclosing creditor pursuant to the procedures of §257-20 of this Code as required by P.L. 2014, c. 35.

SECTION 2. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

SECTION 3. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Delran declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

SECTION 4. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.

RESOLUTION DIRECTING THE DISTRIBUTION OF THE TOWNSHIP OF DELRAN NET RETURNED SURPLUS FUNDS HELD IN TRUST BY THE BURLINGTON COUNTY MUNICIPAL JOINT INSURANCE FUND

WHEREAS, the Township of Delran hereinafter referred to as MUNICIPALITY, participated as a member municipality of the Burlington County Municipal Joint Insurance Fund, hereinafter referred to as FUND, for one or more of the following FUND fiscal years beginning January 1, 1999, January 1, 2000, January 1, 2001, January 1, 2002, January 1, 2003, January 1, 2004, January 1, 2005, January 1, 2006, January 1, 2007, January 1, 2008, January 1, 2009, January 1, 2010 and

WHEREAS, the FUND is a statutory filed municipal joint insurance fund as defined in N.J.A.C. 11:15-2.1 et seq., and

WHEREAS, the MUNICIPALITY joined the FUND knowing that membership carries with it joint and several liability with all other member municipalities for each year of the MUNICIPALITY's membership, and

WHEREAS, the MUNICIPALITY understands that the FUND's Executive Committee are the only persons authorized in law to make decisions as to when and how much of any available statutory surplus will be released by the FUND, and

WHEREAS, the MUNICIPALITY understands that the FUND's Executive Committee are the only persons authorized in law to make decisions as to when and how much of any projected deficit will be declared as an additional assessment due to the FUND, and

WHEREAS, the MUNICIPALITY understands that Available Statutory Surplus is defined to be the amount of money in excess of the projected value of claims by line of coverage, plus an actuarially determined value for Incurred But Not Reported claims, subject to the surplus reserve calculations as defined in N.J.A.C. 11:15-4.6 et seq., and subject to review and approval by the Department of Banking and Insurance and Department of Community Affairs, State of New Jersey, prior to release by the Executive Committee of the FUND, and

WHEREAS, the MUNICIPALITY understands that it remains jointly and severally liable into perpetuity despite the earlier release of Available Statutory Surplus due to the possibility that a FUND year wherein a return of Statutory Surplus has been duly authorized could later be presented with a claim for which it could be responsible causing a demand for an additional assessment from each participating member municipality of that FUND year, and WHEREAS, the MUNICIPALITY understands that it remains jointly and severally liable into perpetuity despite the earlier collection of an additional assessment due to the possibility that a FUND year wherein an additional assessment has been duly authorized could later be presented with a need for additional assessments from each participating member municipality of that FUND year, and

WHEREAS, the MUNICIPALITY understands that its options for directing the distribution of its net share of released Statutory Surplus to be as follows:

- 1. Direct the FUND to apply the MUNICIPALITY's share to the MUNICIPALITY's premium as a credit in the next FUND fiscal year (N.J.A.C. 11:15-4.21(e)),
- 2. Direct the FUND to issue a check to the MUNICIPALITY for the MUNICIPALITY's share,
- 3. Direct the FUND to apply the MUNICIPALITY's share to the FUND's Aggregate Excess Loss Contingency Fund (A.E.L.C.F.), which provides member municipalities with an available individual contingency balance for use in satisfying any possible need for a supplemental assessment for any year they were a member and an annual capacity to use all or a portion of a member municipality's available balance in offsetting future premiums, or
- 4. Direct the FUND to apportion the MUNICIPALITY's share as a stated dollar amount among options 1, 2 and 3 above such that the <u>sum total of allocated</u> <u>dollars equals the amount of the Net Distribution available</u> to the MUNICIPALITY as noted above.

NOW THEREFORE, the MUNICIPALITY directs the FUND to distribute the MUNICIPALITY's share of its Net Distribution as follows (check the boxes that apply):

- Apply a portion of the amount as a credit to the MUNICIPALITY's next FUND Year premium.
- Apply a portion of the amount as a check to the MUNICIPALITY.
- Apply the full amount to the MUNICIPALITY's share of the FUND's Aggregate Excess Loss Contingency Fund (A.E.L.C.F.).

Mr. Hatcher – Mr. Hatcher stated that he wanted to comment on a few agenda items. One was Resolution with respect to the Burlington County Joint Insurance Fund. The fund had a dividend of over \$450,000, of which \$50.766.00 was Delran's portion. This will allow us to keep our insurance assessment for 2015 the same as 2014. This has been one of the most successful shared service we have been involved with.

The second item, is the ordinance regarding property maintenance. The state statute now allows us to hold the foreclosing agency responsible for property maintenance issues.

Mr. Hatcher stated that we have completed branch collection and ask that no more branches be placed at the curb until spring. We will be making one more trip through the town for leaf collection.

Mr. Long – Mr. Long congratulated Mr. Morrow on his years serving Delran. He has appreciated working with him through the years.

Mr. Bauer – Mr. Bauer reported that the Fire Department had a very busy month. The rescue from the Chester Avenue Station assisted Burlington Township on a house fire. This was a second alarm rescue so they assisted in any way needed.

The Bridgeboro Station responded to a house fire in Willingboro and were the first to arrive. They did a nice job knocking the fire down with cast. The Bridgeboro Station also responded to the Columbus Mart fire.

Last night, our surface ice rescue team out of the Chester Avenue Station responded to a call of two hunters stuck in the creek in Cinnaminson. They did an outstanding job.

Mr. Bauer stated that on behalf of the Fire Department and Emergency Squad, he would like to thank Mr. Morrow for his support to both organizations over the years.

Mr. Morrow asked if the Fire Department puts information out on their signs to remind residents about the fire concerns with Christmas Trees drying out.

Mr. Bauer stated that they do put information out but this is definitely something to bring up.

Ms. Pangia – Ms. Pangia stated that she would like to start off my stating that Mr. Morrow will be missed as a Councilman. She thanked Mr. Morrow for all the advice and help over the years.

Ms. Pangia stated that she and her family went to the Chinmi Buffet on the day that it opened and had a very nice meal. She also visited Smashburger. She wished them all the best.

Ms. Pangia stated that there are a lot of activities coming up. The Methodist Church is having a Craft Fair this Friday night and the Township's Tree Lighting is also on Friday night. There is a breakfast with Santa at the school on December 6th and at the Chester Avenue Fire House on December 13th.
