

The "Base Bid" includes the site work required for the construction of the +/- 9,500 square foot playground. Alternate 'A' is for the construction of a concrete pad and preparation work for a proposed shade structure. Alternate 'B' includes the site work required a +/- 2,000 square foot expansion of the playground for a swing set.

The Engineer's Estimate for the project was \$106,900 for the base bid, \$17,420 for Alt 'A' and \$21,060 for Alt 'B'. The Engineer's Estimate for the base bid plus both alternates is \$145,380. The average bid price for the base bid plus both alternates for all the bidders less the high bid outlier (Aliano Brothers) is \$145,976.

Based on our review and subject to confirmation by the Township Solicitor, it appears Decker's Inc. is the lowest responsible bidder. Their bid did have one irregularity in that it was not submitted intact, although this irregularity is minor in nature and not a mandatory cause for the bid to be rejected. Decker's Inc. is the apparent low bidder whether the base bid or any of the alternates are awarded.

The second low bidder will depend on whether the Base Bid, Alternate A or Alternate B is to be awarded. Thor Construction is the apparent second low bidder for the Base Bid but should be rejected if Alternate A is to be awarded as their bid submission is missing required documents associated with Alternate A. Think Pavers is the apparent second low bidder if the Base Bid, Alternate A and Alternate B are to be awarded.

The Township received a \$200,000 grant from the Burlington County Park Development Grant program for the playground construction. The park is being developed in partnership with Build Jakes Place (BJP). The Township Council previously committed to funding \$200,000 toward the project costs as well as engineering costs.

Not included in this contract are the purchase and installation of the playground equipment, purchase of pour-in-place rubber safety surface (PIP) and installation of the PIP. The cost for the installation of the shade structure (Alt A) is also excluded from the bid. The playground equipment has been previously purchased by BJP and is being stored at the municipal complex. The PIP materials remain to be purchased via "state contract". The cost for PIP materials will range from \$108,484.75 to \$148,688.50 depending on the color ratio and whether the Base Bid and Alternate B is awarded. The cost for installation of the PIP materials is approximately \$16,756.25 for the Base Bid area and an additional \$3,697.75 for the swing set area (Alt. B). The playground equipment is to be installed by volunteers being organized by BJP and the playground supplier, General Recreation.

Based on this information, we recommend the following actions:

- 1. Award of the contract to the low bidder, Decker's Inc, 16 Lakeside Avenue, Cherry Hill, NJ 08003, within 60 calendar days, on a unit price basis for the base bid in the amount of \$70,702.85 based on available funding. If adequate funding is available, the Township can proceed with the inclusion of Alternate 'A' and Alternate 'B' for a total contract cost of \$90,634.95. The award should be subject to review and approval by the Township Solicitor, the review of the bid bond and surety from the low bidder relative to licensing to do business in the state of New Jersey and appearance on the current list of "Surety Companies Acceptable on Federal Bonds", U.S. Treasury Department, submission of the required bonds and insurance certificates for the project.
- 2. The bid and bid security of the second and third low bidders be retained and held open, pending execution of the contract agreement with Decker's Inc.
