Mr. Hatcher reported that he was asked to give an update on today's storm. The damages included down trees on Haines Mill Road, Spruce Street, Cornell and Bridgeboro Road. There were also two down trees on Conrow Park and Haines Mill Field. Wires were down on Fifth and Brown, Chester and Oberlin. There was flooding in several areas with most dissipating after the rain. Traffic lights were out at Route 130 and Fairview and there was a section of Route 130 near the storage facility had to be closed due to a pole that appeared to be swaying. A large portion of the town was without power and branches are down throughout town. We will begin picking up branches tomorrow.

Solicitor – Mr. Platt reported that we reached out to the Michael's organization after the last work session and they were very happy to be selected to work with the Township on the Abrasive Alloy property. They believe that they are can meet the court order deadlines. We will likely have an agreement to review at the August 25th work session. We have also notified the other presenters of the decision.
