RESOLUTION URGING CRACKDOWN ON BOOM CAR PARTIES

WHEREAS, the residents of Delran Township, like many of their Burlington County neighbors have endured the overnight noise and vibration emanating from “boom car” parties held in the Philadelphia area;

WHEREAS, despite legislative efforts both in New Jersey and Pennsylvania, as well as coordinated law enforcement action on both sides of the Delaware River, the “boom parties” have not only continued but have increased in number and intensity; and

WHEREAS, Burlington County State legislators, law enforcement, and county commissioners recently sent a letter to Philadelphia Mayor Cherelle Parker requesting she crack down on the “boom car” parties that torment the resident living in Burlington County towns along the Delaware River; and

WHEREAS, the Township endorses the local leaders efforts but also urges Mayor Parker and the City of Philadelphia to go one step further and implement measures to hold the property owners of the parcels used for the “boom parties” responsible for these events.

NOW THEREFORE, BE IT RESOLVED by the Township Council of the Township of Delran, Burlington County as follows:

1. The Township urges Mayor Parker and the City of Philadelphia to supplement their efforts to stop boom car parties and to consider penalizing not only the event organizers but the hosting property owners who do not act to prevent the parties occurring on their premises.
2. The Township appeals to its neighboring communities to reach out to Mayor Parker and the City of Philadelphia letting them know the impact of the boom parties on their residents and the need to expand enforcement efforts.
