ORDINANCE 2024-20

AUTHORIZING AND APPROVING THE SALE OF THIRD-PARTY OWNED PROPERTIES KNOWN AS 123 NATALIE ROAD AND 19 FOXGLOVE DRIVE TO THE SALT AND LIGHT COMPANY, INC. AND CONVERSION OF SAID AFFORDABLE UNITS TO A RENTAL UNIT

WHEREAS, COBA, Inc., c/o TD Bank, N.A. owns property, located at 123 Natalie Road, identified on the Tax Map as Block 118, 4.03, Qualifier C0123 and Wells Fargo Bank, N.A. owns property, located at 19 Foxglove Drive, identified on the Tax Map as Block 118.21, Lot 1, Qualifier C0019 (the "Properties"); and

WHEREAS, pursuant to the Fair Housing Act (P.L. 1985, c. 222) (the "Act"), municipalities in the State of New Jersey are required to provide their fair share of housing that is affordable to low-income households in accordance with the provisions of the Act; and

WHEREAS, the Township administers the Township Affordable Housing Program for the purpose of meeting its fair share affordable housing obligation in accordance with the provisions of the Act; and

WHEREAS, the Act requires that municipalities ensure that such designated housing remains affordable to low and moderate-income households for a designated period of time; and

WHEREAS, the Properties are currently designated as a sales unit in the Township Affordable Housing Program; and

WHEREAS, to help satisfy the Township's affordable housing obligation, The Salt and Light Company, Inc. ("Purchaser") has indicated its desire to purchase the Properties and convert them to Affordable Housing rental units; and

WHEREAS, the Township wishes to declare its support of Purchaser's purchase of the Properties and conversion of same to Affordable Housing Program rental units.

NOW, THEREFORE BE IT ORDAINED, by the Council of the Township of Delran, County of Burlington, State of New Jersey that the Council hereby approves the sale of the property commonly known as 123 Natalie Road and the property commonly known as 19 Foxglove Drive to The Salt and Light Company, Inc. and the conversion of same to a rental unit subject to the Affordable Housing Program regulations on rental units; and

BE IT FURTHER ORDAINED that the Purchaser shall notify the Homeowner's Association of Summerhill Condominiums of the foregoing; and

BE IT FURTHER ORDAINED that the Mayor of the Township of Delran and other necessary Township officials shall be and hereby are authorized to execute the appropriate documents necessary to implement said unit conversion on behalf of the Township of Delran.
